## **RECOMMENDATION(S)**

#### **THAT Council:**

- 1. Accept the resignation of Dustin Hall as a member of the Active Transportation Advisory Committee;
- 2. Pass and enact By-Law 27-21 to amend the Terms of Reference for the Active Transportation Advisory Committee to include at all times a member of the FFC Trails Committee; and
- 3. Appoint Doug McCarthy as the FFC Trails Committee appointee to the Active Transportation Advisory Committee.

### **EXECUTIVE SUMMARY**

### **Purpose**

- To amend the Terms of Reference for the Active Transportation Advisory Committee to require a member of the Ferguson Forest Centre (the "FFC") be appointed as a member of the Active Transportation Advisory Committee.
- To accept the resignation of Dustin Hall and the appointment of Doug McCarthy as a member of the Active Transportation Advisory Committee.

### **Key Findings**

- The Municipality of North Grenville has been advised that Dustin Hall of the FFC Trails Committee
  has resigned both from the FFC Trails Committee and the Active Transportation Advisory
  Committee.
- The FFC has recommended his successor, Doug McCarthy, be appointed to the Active Transportation Advisory Committee.

It is advisable to amend the Terms of Reference for the Active Transportation Advisory Committee
to include a member of the FFC Trails Committee to reflect the many partnerships between the FFC
and Municipality, including the trails located at the FFC.

### **Financial Implications**

There are no financial implications associated with this report.

### BACKGROUND

On December 1, 2020, Dustin Hall was appointed to the Active Transportation Advisory Committee. Mr. Hall has resigned from this position both with the FFC Trails Committee and the Active Transportation Advisory Committee. To replace Mr. Hall, the FFC Trails Committee has suggested the appointment of Doug McCarthy.

### **ANALYSIS**

The Active Transportation Advisory Committee's Terms of Reference mandates that the Committee implement the integrated trails strategy within the Municipality of North Grenville and to expand, enhance and promote a Municipal active transportation system, including both on land and water.

Due to the importance of the FFC to the implementation of the Committee's mandate, and the working relationship between the FFC and the Municipality, it is desirable to appoint a member of the FFC Trails Committee to the Active Transportation Advisory Committee.

As the Municipality works to enhance the trails network for recreational and active transportation use, the knowledge and expertise of a member on the FFC Trails Committee would be a welcome asset to the Active Transportation Advisory Committee
