A By-Law to Appoint Municipal Officers for the Municipality of North Grenville

AND WHEREAS Council of the Municipality of North Grenville deems it advisable to amalgamate officer appointments into a single By-Law for to appoint all Municipal Officers:

NOW THEREFORE BE IT RESOLVED that the Council of the Corporation of the Municipality of North Grenville enacts as follows:

- 1. That Schedule 'A', attached hereto, forms part of this By-Law.
- 2. That the persons identified in Schedule 'A' have been appointed as officers and/or agents of the Municipality of North Grenville.
- 3. That the Clerk of the Municipality of North Grenville is hereby authorized to make any minor modifications or corrections of an administrative, numeric, grammatical, semantic or descriptive nature or kind to the By-Law and schedule(s) as may be deemed necessary after the passage of this By-Law, where such modifications or corrections do not alter the intent of the By-law.
- 4. That this By-Law take full force and effect upon the final passing thereof.
- 5. That By-Law 59-24, as amended, be repealed.
