Mayor Michael Cameron thought it would benefit the Merrickville-Wolford community to have the municipality take care of their own expenses.

Merrickville-Wolford representatives and staff supported Option #2 presented with respect to budget allocation from each Municipality.

Chief Administrative Officer Darlene Plumley noted preference for a 60% for North Grenville, 40% for Merrickville-Wolford.
